

# Strengthening links with academic leaders of UNICA Member Universities



During the past two academic years, we worked towards reinforcing the relationship with Rectors and Presidents of UNICA Member Universities. To this end, we enhanced our communication with academic leaders by increasing the frequency of our **newsletters** (from quarterly to monthly), preparing special editions of "Newsflash for Rectors and Vice-Rectors" (2-3 per year) and rais-

ing the number of meetings addressed for representatives of academic leadership. **Seven Rectors meetings,** including **three dedicated Rectors Seminars** to be held in the academic year 2017/2018, will offer new opportunities for academic leaders from UNICA Member Universities to meet and exchange experiences on issues of strategic importance in different areas of university activity. As working with female academic leaders from UNICA Member Universities and encouraging their involvement in the activities and the decision-making of the Network remains our priority, we will pursue our cooperation with the **European Women Rectors Association (EWORA)**.

# **Strengthening the University-Capital** 4 City relationship



Published in May 2017, the European Commission's Communication on a renewed FU agenda for higher education stressed the role of university and city/region collaboration in tackling future skills mismatches, building inclusive higher education systems, ensuring HEIs' contribution to the region's smart specialisation, and supporting effective and efficient higher education

systems. Through the "University, Culture and the City" initiative and UNICA's involvement in the Diplomatic, Academic, Economic (DEA) Missions organised in collaboration with CIDIC (International Consular and Diplomatic Circle). we want to stress the common characteristic of UNICA Member Universities: their location in Capital Cities, their place in the Cities' social, cultural, economic life, and the role they play in urban and regional development.

# **Fast-tracking professionalization** of university staff



Changes in the European Higher Education landscape have an impact on almost every iob performed at the university: the roles of university professionals are changing and new competencies are needed as the staff takes on new roles, tasks and responsibilities. Conscious of the major role of training and continuous competence development of university staff, UNICA

will continue to organise meetings which serve as a forum for new information, exchange of good practices and capacity building for different representatives of university community and to facilitate the development of the EU-funded project proposals that can respond directly to the hurdles faced by university staff in their day-to-day work. Moreover, further development of the IMOTION Staffmobility.eu platform, enabling the publication of more types of short-term and long-term staff training opportunities, is envisaged for the next academic year.
