29 February | Opening Session

Sorin Costreie | UNICA President (Overall Chair)



Prof. Sorin Costreie was elected to the position of UNICA President in June 2023. He was previously Vice-Rector for Public Relations and University Networks (2019-2024) and Vice-Rector for International Relations of the University of Bucharest (2017-2019), as well as former Vice-Dean of the UB Faculty of Philosophy (2016-2017). He is a member of the University Senate since 2011. In between, in 2016, he was Adviser to the Minister and State Secretary in the Ministry of Education and Scientific Research. He was also in the period 2020-2023 State Advisor to the Prime-Minister for Education and Research.

He is Associate Professor at the Department of Theoretical Philosophy, University of Bucharest. He holds a PhD in Philosophy (University of Bucharest, 2007), with a thesis in philosophy of mathematics, and pursued further doctoral studies in philosophy of language at the University of Western Ontario, Canada between 2000 and 2008. He has published articles, books and edited volumes with Routledge, Springer, Oxford University Press, Taylor & Francis, Elsevier, Humanitas, University of Bucharest Press, etc.

He was awarded several scholarships and fellowships to study for extended periods in Canada, United States, Germany, Spain, and Italy. His area of interest has lately focused on mathematical cognition and critical thinking. He is member of various professional associations, and since 2014 he is member of the Steering Committee of the European Society of Analytic Philosophy.





Iliana Ivanova | Commissioner Innovation, Research, Culture, Education and Youth (Video address)



Iliana Ivanova serves as European Commissioner for Innovation, Research, Culture, Education and Youth since 2023. Her responsibility include ensuring the efficient implementation on the Horizon Europe programme, continuing to build a true European Research Area in cooperation with Member States, and implementing the Erasmus+ programme.

Ivanova was previously a member of the European Court of Auditors between 2013 and 2023. She has been a rapporteur for 27 audit assignments, including on topics such as: regional development and cohesion; the Youth Unemployment Initiative

and the Youth Guarantee; and the European digital agenda, innovation, digital skills and education. Prior to that, she was a Member of the European Parliament, elected in 2009. As a member of the European People's Party (EPP) Group, she sat on the Committee on the Internal Market and Consumer Protection and the Committee on Budgetary Control, on the latter of which she served as vice-chair. She also took an active part in the work of the Special Committee on the Financial, Economic and Social Crisis, where she was vice-chair. Born in 1975, Ivanova studied international economic relations at the University of Economics in Varna (Bulgaria) and holds a Master's degree in international economic relations from the same institution. She was a coordinator for international financial institutions at the Bulgarian Ministry of Agriculture and Food from 1999 to 2002 and was an investment and business analyst in various financial and banking institutions in the US from 2004 to 2006. She also holds an MBA in Global Management from Thunderbird School of Global Management (Arizona State University, US).

Ligia Deca | Minister of Education of Romania (Keynote Speaker)



Ligia Deca is the Minister of Education of Romania. Before ascending to this role in 2022, she served as Presidential Adviser for Education and Research. She is also a member of the Fulbright Commission Board of Directors in Romania. Ligia coled 'Action Track 3: Teachers, Teaching and the Teaching Profession' within the framework of the 2022 United Nations Transforming Education Summit and since June 2023 was co-opted by the UN Secretary General as a member of the Highlevel Panel on the Teaching Profession. Between 2010-2012, she was head of the Bologna Secretariat, supporting the Bologna Follow-Up Group within the frame of the European Higher Education Area. Ligia has worked as an expert for the Council

of Europe, European Commission, EQAR, DAAD and others and in 2014 she was invited to be a member of the 'Science in Education' Expert Group set-up by the European Commission. From 2008 to 2010, she was the President of the European Students' Union. Ligia holds a PhD in Political Science, awarded by the University of Luxembourg in 2016 for her research focusing on the internationalisation of higher education.





Igor Papič | Minister of Higher Education, Science and Innovation of the Republic of Slovenia (Speaker)



Dr Igor Papič was born on 24 May 1966 in Ljubljana. He is a Professor at the Faculty of Electrical Engineering of the University of Ljubljana. From 2011 to 2013, he was the Vice Dean for the field of pedagogical work, from 2013 to 2017 the Dean of the Faculty, and from 2017 to 2021 the Rector of the University of Ljubljana.

He holds bachelor's, master's and doctoral degrees from the Faculty of Electrical Engineering, University of Ljubljana. In the 1990s, he was a trainee at the Siemens Power Transmission and Distribution Department in Erlangen, Germany. In 2001 he was a visiting professor at the University of Manitoba in Winnipeg, Canada. He has

led numerous national and international research and development projects. In 2009, together with his partners, he founded one of the first spin-off companies of the University of Ljubljana. He has been invited to lecture at the University of Manitoba, the University of Manchester, the University of Alberta, Sichuan University and elsewhere.

From 2006 to 2017, he was Chair of the Programme Council of the Smart Grid Technology Platform. He is President of the Electrotechnical Association of Slovenia. He was one of the initiators and the first President of the Rectors' Forum of the Universities of South-Eastern Europe and the Western Balkans, and in 2020 he was the first President of the EUTOPIA European University Alliance.

He is committed to a knowledge-based society and to accelerating the transfer of knowledge from academia to everyday life, which is a prerequisite for the successful development of Slovenia in the coming decades.

Julio Cañero Serrano | Vice Rector for International Relations, University of Alcalá and Member of the UNICA Steering Committee (Chair)



Julio Cañero Serrano is Vice Rector for International Relations and an Associate Professor at the University of Alcalá. His research focuses on the study of the culture, politics, and society of the United States of America, with an emphasis on the literary and linguistic traditions of the Latino population in that country. He is the director of the Benjamin Franklin Collection (2013) and the academic journal REDEN (2019), both belonging to the Research Institute in American Studies "Benajmin Franklin." In the field of knowledge transfer, he has participated in various media as a specialist in North American Studies.





Maria Walsh | Member of the European Parliament (Video Message)



Maria Walsh was elected as a Member of the European Parliament for the Midlands–North-West constituency at the 2019 European Parliament elections. She is the youngest Irish MEP in the European Parliament. Maria was born in Boston, USA, but the village of Shrule, Co. Mayo has been home for her since 1994. She graduated from Griffith College Dublin with a B.A. in Journalism and Visual Media in 2009 and went on to a career in television production and creative management, working in Dublin, New York and Philadelphia.

In the European Parliament, Maria is a full member of the Committee on Employment and Social Affairs (EMPL), and the Committee on Culture and Education (CULT). She is also a substitute member of the Committee on Civil Liberties, Justice and Home Affairs (LIBE). She is also the only Irish EPP representative on the Delegation for relations with the United States and the Delegation for relations with the African, Caribbean, and Pacific Group of States. Furthermore, Maria is Vice-Chair of the LGBTI Rights Intergroup in the European Parliament, which advocates for equality in the EU and monitors Member States' legislative initiatives. She consistently advocates for equality, inclusion and diversity within her policy and legislation work. As a Co-Chair on both the Mental Health Alliance and the Coalition of Mental Health and Wellbeing Intergroups in the Parliament, Maria is dedicated to raising the cross-sectional impacts of mental health throughout her policy work. With her work on these two Mental Health Intergroups, Maria is leading the call for an EU Year of Good Mental Health to ensure that we are prepared for the oncoming mental health crisis which will follow the pandemic.

In 2014, Maria was crowned the International Rose of Tralee, at the festival of the same name that celebrates young women of Irish heritage. As the first openly gay Rose of Tralee in 2014, she used her platform to advocate for a positive vote in the Marriage Equality referendum in 2015. Up until July 2019, Maria served as a member of the Irish Reserve Defence Force in the First Armoured Cavalry Squadron, based in the Curragh Co. Kildare.

Alexandra Duarte | UNICA Project and Communications Officer (Presentation)



Alexandra Duarte joined UNICA in October 2020, after a previous traineeship of almost one year in 2019.

She is mainly responsible for UNICA's communication. She has a background in Communication, to which she allies an experience in International Higher Education after working in the area of International Relations at NOVA University Lisbon. In the previous years, she also worked at the Communications Office of the same University.





Rita Dias | President of the Erasmus Student Network (Speaker)



Rita is 27 and comes from the coast of Portugal. She has a bachelor's in Political Science and International Relations and a Master's in Public Policy. Rita did her Erasmus in Leuven, Belgium, and worked at the United States Embassy in Lisbon in 2018 and in the Political Observatory in the Association for Political Studies and Scientifical Research in 2020. She joined ESN in 2018 when she moved to Lisbon to start her master's. She held several positions in the network, such as President of Portugal and Liaison Officer for Inclusive Mobility. As president, she is responsible for the general coordination of the organisation, external relations,

policy, and advocacy. Her main priorities include increasing participation in learning mobility and fostering civic engagement and participation of young people through Erasmus.

Zygmunt Lalak | Vice Rector for Research, University of Warsaw (Speaker)



Prof. Zygmunt Lalak graduated from the Department of Technical Physics and Applied Mathematics of the Warsaw University of Technology (M.Sc. in 1985). His scientific career has been associated with the Department of Physics of the University of Warsaw, where he received his doctoral degree (1990) and habilitation (Dr Sc. 1999). In 2008, he obtained the state-awarded title of the professor. As of 2003, Prof. Zygmunt Lalak is an associate professor and as of 2013 full professor of the University of Warsaw. In years 2016-2020, he was the Vice-Dean for Research and Development at the Faculty of Physics at the University of Warsaw.

Prof. Zygmunt Lalak had been working for many years in the leading research institutions in the area of elementary particle physics: in the laboratory CERN (Switzerland), at the University of Oxford (UK), at the University of Pennsylvania (USA), at the Technical University in Munich and the University of Bonn (both in Germany). He authored more than 120 scientific papers published in the leading international journals and supervised 8 completed PhD degree procedures. He chairs the Scientific Council of the Discipline Physical Sciences. Prof. Zygmunt Lalak is a member of the Coordination Committee of the Priority Research Area POB 2 "Beyond Micro and Macro Worlds" as part of the "Initiative of Excellence – Research University" programme at the University of Warsaw.

Horia Onița | President of the European Students' Union (Speaker)



Horia Onița serves as the President of the European Students' Union, working on overarching political priorities (such as the Bologna Process, European elections), quality assurance of education, learning and teaching policies, digitalisation and social dimension of higher education. He represents ESU in positions such as cochair of the Drafting Committee of 2024 Tirana Communique, co-chair of the Bologna Follow-Up group on Social Dimension and member of European Quality Assurance Register Board and BFUG Board. He also follows EU developments on education funding and the European Semester and has been representing ESU

in the Steering Committee on Education of Council of Europe. Horia holds a Bachelor of Law as valedictorian and a LLM of Public Procurement from the University of Bucharest.





Florian Trauner | Dean of the Brussels School of Governance at the Vrije Universiteit Brussel (Speaker)



Florian Trauner is the Dean of the Brussels School of Governance (BSoG) at the Vrije Universiteit Brussel. Situated in the heart of Europe, the BSoG strives to be a hub for interdisciplinary teaching and cutting-edge research. Its purpose is to understand and help tackle key societal dynamics and challenges such as migration, the digital transformation of society and climate change. Research-wise, Florian Trauner has been interested in the EU's institutions and decision-making as well as policy outcomes in the fields of asylum, migration, border controls and policing. He is a regular Visiting Professor at the College of Europe (Natolin

Campus) and has held permanent or visiting positions at the University of Vienna, Renmin University of China (in Beijing), Sciences Po Paris and the EU Institute for Security Studies. He also acted as an external expert for different EU institutions and UN organisations.

Henrik C. Wegener | Rector, University of Copenhagen (Speaker)



Henrik C. Wegener was appointed as Rector of the University of Copenhagen on March 1, 2017. He holds a MSc in Food Science (1988), a PhD in Microbiology (1992, The Royal Veterinary and Agricultural University), a Master of Public Administration (2007, Copenhagen Business School).

Previously, he worked as research assistant, researcher, centre director, research professor and head of research at the National Veterinary Serum Laboratory and the Danish Institute for Food and Veterinary Research in the period 1988-2007. He was the Director of The National Food Institute at the Technical University of

Denmark (DTU) between 2007 and 2011, and Provost, Executive Vice President of DTU between 2011 and 2017. He was a Seconded National Expert for the World Health Organisation (WHO) in 1999-2000, and the Chairman of the Scientific Advice Mechanism of the European Commission (EC SAM) in 2015-2017.

Romiţă lucu | Coordinator of the UNICA EduLAB, Co-Chair of the FOREU Subgroup on the European degree, Ambassador of the Magna Charta Observatory, and former Member of the EUA Learning and Teaching Steering Committee Initiative (Chair)



Professor Romita IUCU is the President of the Board of Trustees, of the renowned higher education institution in Romania's Capital City, the University of Bucharest and professor at the Department of Educational Sciences. He has been appointed as Steering Committee Member of the EUA – European University Association, Teaching and Learning Initiative. Professor lucu held several professional and management positions (former Acting Rector of the University of Bucharest 2016-2017, Vice-Rector for Academical Affairs, for more than 16 years)on designing,





managing and validating higher education and adult education policies, at international and national level. He was, since 2010 to 2015, the ENTEP Coordinator (European Network on Teacher Education Policies) and between 2016-2017 country representative in The BFUG - Bologna Follow-up Group. In the field of Policy analysis and development: Vice-President National Council for Educational Reform, EU - member of Cluster Teachers and trainers, EU - member of the Expert Group on Improving the Education of teachers and trainers, in 2015-2016, he was the Coordinator of QUALITAS - Barometer of Higher Education (National Agency for Quality Assurance in Higher Education), MofE Ministry of Education and Research (deputy general director, designed and implemented the National Strategy for Adult Education), Consultant for Teacher Training Policies, National Socrates Agency / EURIDYCE - consultant for lifelong learning policies and country expert in the Modernization of Higher Education in Europe -Academic Staff - 2017, UNICEF - Coordinator for National Project – Strategy for Preschool Teacher Training, World Bank expert for rural Romanian Education. Since 2011 he has been inducted as a member of the International Adult and Continuing Education Hall of Fame. He was working for ECORYS as country expert dealing with NRP, Themes of the Ad-Hoc requests, country updates. As a relevant experience to this assignment, Prof. lucu was selected as senior expert in the Project: "Development of the capacity of the Ministry of National Education to monitor and forecast the evolution of higher education in relation to the labour market - SIPOCA 3", coordinated by the Romanian Academy of Sciences.

Milan Zver | Member of the European Parliament (Video Message)



Born in 1962. Ljubljana. Graduated from the political science department of the Faculty of Social Sciences at the University of Ljubljana, 1987. M.Sc. in 1990 and PhD at the University of Ljubljana, 1998. A member of Slovenian Democratic Party. Dr Zver served as advisor to the deputy prime minister Jože Pučnik and later to the minister of defence Janez Janša. Municipal Councillor in Ljubljana. Member of several executive bodies and twice Vice-President of the Slovenian Democratic Party (SDS). He was elected to be a member of the Slovenian National Council and National Assembly. Minister for Education and Sports, 2004-2008. During the

Slovene presidency of EU in 2008 serving as President of the Council of European Union for Education, Youth and Culture and in 2009 was elected to the European Parliament. He was a Member of Prague's Platform of European Memory and Conscience and a member of the Central Committee of Berlin's forum Dialog-Kultur-Europa. Actively involved in many activities of KAS and IRI. Author of several books. MEP since 2009.

Marcos Ros Sempere | Member of the European Parliament (Video Message)



Marcos Ros is a Spanish Member of the European Parliament, in the Group of the Progressive Alliance of Socialists and Democrats. and full member of the Committee on Culture and Education. He is professor on leave of absence in urban planning at the Cartagena School of Architecture. He has been the shadow rapporteur for the European Parliament report on the European Education Area, and is a very active member in matters relating to education, universities and Erasmus+.





Marie-Anne Persoons | Advisor International Policy at the Department of Education and Training of the Flemish Community of Belgium (Keynote Speaker)



Dr Marie-Anne Persoons is Advisor International Policy at the Department of Education and Training of the Flemish Community of Belgium. She graduated in Oriental Languages and History (section of Indo-Iranian studies) from the Catholic University of Leuven in 1984. In 1984-1985 she continued studying Chinese language at the National Taiwan Normal University. Further studies in Leuven include a postgraduate degree in Philosophy (1988) and a Ph.D. in Oriental studies (1995). More recently she obtained a Master degree in Public Management from the University of Antwerp (2008).

Apart from sworn interpretation from/to Chinese at the Court of Antwerp, her first professional experience was connected to teaching and research at the Catholic University of Leuven and the Antwerp Royal Academy of Fine Arts, as well as the Antwerp Institute of Art History. With the latter she still remains affiliated. In 1996 she joined the Flemish Department of Education and Training and has been working in international education policy ever since, initially mostly in relation to the EU Education Committee and the Bologna Follow-up Group, chairing both bodies in 2001. From 2007 to 2009 she was general coordinator of the Benelux Bologna Secretariat before joining the European Commission as national expert (2009-2011). Since 2012 she has coordinated her department's multilateral and bilateral dossiers and participated in several UNESCO, OECD, COE and BENELUX policy forums, such as the UN's SDG-Education 2030 Steering Committee (2016-2021) and as Chair of the OECD's Education Policy Committee (2018-2021). Since 2021 she serves as vice-chair of the Council of Europe's Steering Committee for Education, which administrates a work programme with focus on education for human rights, democracy and rule of law. Scientific publications include articles related to the field of Asian culture and to international (higher) education policy, as well as course materials connected to her teaching experience.

Vanessa Debiais-Sainton | Head of Unit Higher Education, Directorate General for Education, **Youth, Sport and Culture (DG EAC)** (Keynote Speaker)



Vanessa Debiais-Sainton is Head of the Unit in charge of European Higher Education policies and programme at the European Commission's Directorate General for Education, Youth, Sport and Culture. The unit is the lead service for the development and implementation of the European Education Area's higher education dimension, including the European Strategy for Universities presented in January 2022. This includes the development and implementation of flagship initiatives such as: 'European Universities' alliances, a joint European degree, the European student card initiative, a European Approach to Micro-credentials, the

automatic recognition of higher education qualifications, tracking graduates and the higher education strand of Erasmus+. In previous posts in the European Commission, Vanessa has worked in DG Research and Innovation. Before moving to the European Commission in 2006, Vanessa spent eight years working for several chemical companies.





Anna-Lena Claeys-Kulik | Deputy Director for Policy Coordination & Foresight, European University Association (EUA) (Speaker)



In her position as Deputy Director of Policy Co-ordination, Anna-Lena contributes to ensuring coherent policies for universities as well as overall policy development and managing cross-cutting issues with policy relevance.

Between 2011 and 2016 Anna-Lena worked on project management and policy development in the area of university funding and governance. Prior to joining EUA, Anna-Lena worked at the European Commission's Directorate General for Education & Culture in the Unit for Higher Education and the Erasmus Programme. Anna-Lena holds a Master's degree in European Political and Administrative

Studies from the College of Europe in Bruges, Belgium as well as a Magister degree in Communication Science, Political Science and Philosophy from the University of Münster, Germany. During her studies she also spent one year at the Institute of Political Sciences of Bordeaux/France.

Elisa Gambardella | President, Lifelong Learning Platform (LLLP) (Speaker)



Elisa Gambardella was elected President of the Lifelong Learning Platform in 2023, after two years contributing to the work of the Steering Committee of the LLLP and representing it in the Board of Civil Society Europe. Her home organisation is SOLIDAR Foundation, where she is Education and Lifelong Learning Coordinator since 2020, and that she originally joined as Political Adviser in 2018. Elisa has represented SOLIDAR also as a member of the CSOs Convention for the CoFoE and as a member of the plenary of the Conference on the Future of Europe. Before moving to Brussels, she worked for the Cabinet of the Italian Minister of Labour,

where she specialised in active labour market policies for youth employment. Overall, she has 10 years' experience in public authorities, think tanks and EU CSOs. She holds a master's degree in European Studies from Roma Tre University.

Marie-Hélène Jobin | Vice Rector for Partnerships and International Relations, University of Luxembourg (Speaker)



As Vice-Rector for Partnerships and International Relations of the University of Luxembourg, I support the development and consolidation of the University's third mission which consists in contributing to social, cultural and economic development of the society. I oversee the development of our agreements with the public and private sectors, the research transfer in collaboration with industry partners and the develop our industrial chairs.

The third mission also includes incubation and acceleration programmes. We are striving to develop an entrepreneurial mindset within the University of

Luxembourg community. With the support of my teams, I also oversee the development of the University's intellectual property, the support of researchers in their invention process and the spin-off of companies resulting from the creativity and know-how of our researchers.





Internationally, my team and I manage relations with other institutions and inter-university alliances. International mobility is compulsory at the University of Luxembourg, and international students represent over 60% of the student body, coming from more than 130 countries. The University of Luxembourg is ranked among the best universities in the world for its international character. The University of Luxembourg is also proud to play a role in capacity building in university networks in developing countries.

Finally, the Vice-Rectorate for which I am responsible also supports the University's commitment to society through public engagement, outreach initiatives and a citizen science approach. Before joining the University of Luxembourg in 2023, I had a rich academic career in Canada, notably at HEC Montréal. I am a full professor of operations and logistics management and an experienced higher education officer. I define myself as a pedagogue at heart, with a particular commitment to continuing education. I taught mainly at MBA and EMBA level in my carrier, focusing on topics such as innovation, process improvement and strategy. Over the course of my career, I've been responsible for managing of a teaching department, pedagogical development (including the management of the HEC Montréal Case Centre and the editorial management of the RICG), programme management and in charge of the complete M.Sc. portfolio at HEC Montréal. In recent years, I have focused my career on international relations with other institutions and on building partnerships. During my career, I have also built and developed a research transfer hub, Pôle santé, dedicated to training, research and coaching in healthcare management. I'm still an active researcher in this field.

Stéphane Lauwick | European Quality Assurance Register (Speaker)



Stéphane Lauwick joined the University Le Havre Normandy (France) in 1994 and became the head of the Electrical Engineering Department of its University Institute of Technology (IUT) in 2001. He was elected Director of the Life Long Learning Centre and Apprenticeship Training Centre of the University in 2007. In that function he was in charge of relations with industrial stakeholders, microcredentials, recognition of prior learning and apprenticeships, all of which he actively promoted in European circles. He became the director of IUT Le Havre in 2010 and served several terms as vice-president in charge of international relations

for the Assembly of Directors of IUTs, which represents all 108 French IUTs, 9500 academics and 180,000 students. As such, he joined the board of EURASHE, eventually becoming the president of EURASHE after the 2015 Yerevan conference. He actively promoted the role of Professional Higher Education in Europe as a provider of knowledge and competences for a diverse student body and stressed its relevance to present-time issues. He was elected president of EQAR in May 2023 and indicated that one of his priorities would be to advance on the road to true automatic recognition by facilitating the cross-border operation of EQAR registered agencies and the application of the European Approach for Quality Assurance of Joint Programmes.





Liviu Matei | Head of the King's School of Education, Communication & Society (Speaker)



Liviu Matei is a Professor of Higher Education and Public Policy, and Head of the School of Education, Communication and Society at King's College London. He served as Provost of Central European University (CEU), including during the time when this university was forced out of Hungary and relocated to Austria. Liviu Matei taught at universities from Europe, the U.S. and Asia, consulted extensively in higher education policy and conducted research and policy projects for the World Bank, UNESCO, OSCE, Council of Europe, European Commission, Nordic Council of Ministers, other intergovernmental and international non-governmental

organisations, national authorities and universities from Europe and Asia. He was a founding Vice-Chancellor of Open Society University Network and a founding member of the Steering Committee of CIVICA- the European University of Social Sciences. He is a Trustee of American University of Central Asia and a member of the Governing Council of Magna Charta Universitatum. He serves on the editorial boards of Internationalisation of Higher Education Journal: Policy and Practice and the European Journal of Higher Education. Currently, he leads the team developing a proposal for a monitoring mechanism for the fundamental values of higher education in the European Higher Education Area.

Anastas Gerdjikov | Former Rector of Sofia University "St. Kliment Ohridski" and member of the UNICA Steering Committee (Chair)



Prof. Dr Anastas Gerdjikov is the former Rector of Sofia University "St. Kliment Ohridski", the oldest and largest University of Bulgaria.
